We are aware of how difficult it can be for the incarcerated individual to make money. We know how the system is set up: paying you pennies per hour if you are fortunate enough to have a job, inciting you to break the rules to work your hustle, or using you to siphon money from family and friends to pay for hygiene, clothing, footwear, and food. We at Goods for a Cause have a heart for prisoners and their loved ones. We want to help.

We propose to create apparel and merchandise using your *original designs* to sell in our online store. Your designee will receive a royalty for each item we sell bearing your design. Here's how the breakdown works:

- 20% goes to a local church
- 20% goes to a cause you select
- 20% goes to our parent nonprofit, Total Worship
- 20% goes to your designee
- 20% goes to Goods for a Cause

We chose this breakdown because it aligns with our mission, vision, and values. We give to the church first because the kingdom of God and His work takes priority (Matthew 6:33). We take this very seriously. We also know how important it is – and yet how difficult it can be – for you to give back to the community you've harmed. Thus, we make donations to the cause of your choice in your name. In addition, we give back to Total Worship to aid their development of materials, workshops, etc. and support the Total Worship community. Without them we would not exist. The remainder is split between your designee and us, Goods for a Cause. As you can see it is to our advantage to help you prosper.

We reserve the right to do business as we deem appropriate, including rejecting or modifying designs, or discontinuing merchandise at any time, for any reason. Your design will not be returned. This is not an application for employment. If your design is approved, we will send you quarterly updates. The royalty breakdown percentage (the 20% paid to each of the five categories) is calculated after the cost of goods sold. While incarcerated, we will send your royalties to your Designee listed above on a quarterly basis. Your Designee cannot be currently incarcerated. You must fill out the entire submission form to be considered. Write legibly. If you agree to these terms/conditions, please sign below. Thank you.
